### 4.0 Scope of the Memorandum:

4.1	The First Party and the Second Party agree to collaborate in all academic activities connected with COURSE.
4.2	The PARTIES hereby agree to follow the Regulations & Syllabus for the COURSE as show in Annexure A, which has been approved by the competent authorities of the both the PARTIES.
4.3	The PARTIES agree that the COURSE is offered by the FIRST PARTY under Yearly system with Self supporting Mode and also agree to recognize as a certificate Course which will be conducted by the SECOND PARTY.
4.4	The COURSE shall be conducted on Full Time Basis for one Year as mutually agreed upon by the PARTIES.

### 5.0 Duration of the Course:

5.1	The duration of the course shall be on year consisting of year wise System with the performance evaluated on marks.
5.2	For the conduct of the course, Mr. P. Kesava Prasad, a CO-ORDINATOR nominated by M/s. Akhila Bharata Kuchipudi Natya Kala Mandali, Kuchipudi shall be the Authorized Agency for the FIRST PARTY.
5.3	For the conduct of the course, a COURSE DIRECTOR or representative nominated by the Vice-Chancellor of Krishna University shall be the Authorized Agency for the SECOND PARTY.

### 6.0 Course Structure and Content:

6.1	The FIRST PARTY shall prepare the structure of the Course, syllabi and Scheme of Examination through the standard procedures which will be adopted by the SECOND PARTY as per University Academic regulations. Further, it will come into effect from 2020-21 onwards.
6.2	The FIRST PARTY shall take two representative(s) of the SECOND PARTY into the Board of Studies/Expert Committee constituted for development of Course Structure, Syllabus and Scheme of Examination.
6.3	The COURSE CO-ORDINATOR and COURSE DIRECTOR shall implement the teaching of course content developed by the FIRST PARTY.

### 9.0 Venue of the Course:


9.1		Two venues shall be used for the conduct of the course. The theory subject shall be taught as Krishna University campus, Machilipatnam and the Practical, E.P.L components / Industrial training / internship programmes shall be taken up at Kuchipudi Natya Mandali, Kuchipudi, Krishna District. The duration of the course to be taken up on each campus will be decided depending on the course content and practical training etc., with the mutual consent of both the PARTIES.
9.2		When the course is conducted at, Akhila Bharata Kuchipudi Natya Kala Mandali, Kuchipudi, Krishna District and the SECOND PARTY shall provide class room(s), and also other facilities required without any charges to the FIRST PARTY.
9.3		The SEOND PARTY shall provide the equipment, instruments available within their premises for the conduct of practical classes programs free of cost.
9.4		Remuneration to the staff of Akhila Bharata Kuchipudi Natya Kala Mandali, Kuchipudi, Krishna and other industry based staff for conducting classes shall be fixed by the FIRST PARTY in consultation with the SECOND PARTY by following the rules and regulations of Krishna University.

### 10.0 Notification of the Course:

10.1		The PARTIES shall mutually decide upon all matters concerned with the issue of the notification of the COURSE for the information of the public.
10.2		Before making the notification as mentioned in para 8.1 the COURSE DIRECTOR shall obtain written approval of the draft of the notification, application format etc., from the Registrar, Krishna University.
10.3		At the time of notification of the Course, the COURSE DIRECTOR shall make available the approved syllabus and the curriculum of the Course for the information of the interested public.
10.4		The expenditure connected with the printing, issuance of the notification and such other matters relating to the Course shall be met by the FIRST PARTY.
10.5		The format for the application form seeking admission to the Course shall be framed by the COURSE DIRECTOR with the written approval of the Registrar, Krishna University.
10.6		The responsibility of printing the required number of the application forms shall vest with the COURSE DIRECTOR following the conditions agreed upon by the FIRST PARTY. These conditions shall be reviewed at the end of each academic year. The format and the number of the application forms to be printed shall be taken up with the written approval of the Registrar of the university.
10.7		All the expenses connected with the preparation of the Syllabus and Curriculum and the notification shall be met by the FIRST PARTY.

### 11.0 Fees for the application form and for the Course:

11.1	The application forms shall be supplied by the university and the cost of application shall be fixed by the FIRST PARTY.
11.2	The tuition fees and other fees to be paid by students for Course shall be fixed as per the norms of the FIRST PARTY and shall be shared in 40:60 ratio by the FIRST PARTY and SECOND PARTY respectively at the beginning of the Course.
11.3	The cost of the application form, tuition fee and other fees for the Course shall be paid by the student in the form of a Demand Draft drawn on a schedule bank in favour of the Registrar, Krishna University / online challan to the notified account of Krishna University, as it decided by Krishna University. The entire fees collected other than tuition fee will be retained by the University.
11.4	The fees paid shall not be refundable under any circumstances
11.5	The PARTIES reserve the right for admitting of the candidates and refuse admission without assigning any reasons thereof.

### 12.0 Responsibilities of the Parties:


12.1	The COURSE DIRECTOR shall be responsible to co-ordinate with the university for admission process.
12.2	The COURSE DIRECTOR shall be responsible to send the fees received (both the application fees and the Registration fees) to the Registrar, Krishna University as soon as they are received.
12.3	The COURSE DIRECTOR shall be responsible to conduct the entrance examination if necessary as per the regulations and procedures laid by the university.
12.4	The maximum number of students to be admitted to the Course shall be decided by the FIRST PARTY in consultation with the SECOND PARTY.
12.5	The COURSE DIRECTOR shall be responsible for conducting the Course in coordination with the authorized agency of the second party.
12.6	The COURSE DIRECTOR & COURSE CO-ORDINATOR shall be responsible for providing hands on training for the students at the premises of the industry and university. The COURSE DIRECTOR & COURSE CO-ORDINATOR shall be responsible for providing adequate and appropriate classrooms at the premises of the industry and university. The COURSE DIRECTOR shall be responsible for providing the materials, stationery, reading materials and library facilities etc., for the COURSE.

### 13.0 Responsibilities of the Parties:


13.1	The COURSE DIRECTOR & COURSE CO-ORDINATOR shall be jointly responsible for providing the faculty for the COURSE. While deciding the faculty for the Course. Wherever possible and applicable, faculty from the both the PARTIES shall be included on mutual consensus.
13.2	The remuneration to the faculty shall be paid by the FIRST PARTY as per the norms of the University.

### 14.0 Responsibilities of the Parties:

14.1	The PARTIES, periodically, once in three months, shall meet and prepare reports in writing on the progress of the COURSE and signed by them. Copies of the reports shall be sent to the university.

#### 15.0 Miscellaneous:

15.1		The COURSE DIRECTOR shall recommend and make payments like remuneration for the guest faculty and other miscellaneous expenditure as per the approved rate of the university to the SECOND PARTY.
15.2		The COURSE DIRECTOR shall prepare a progress report on the course at the end of each semester or for a period of six months.

#### 16.0 Conduct of Examination and Award of Degrees:

16.1		Krishna University shall conduct the examination as per the rules of the university and award the degrees to the successful candidates.
16.2		The COURSE DIRECTOR & COURSE COORDINATOR shall be jointly responsible for computing the internal assessment component submitted by the teachers.

#### 17.0 Renewal and Termination of Agreement:

17.1		This agreement shall be renewed at least before the expiry of two years, and a fresh agreement shall be signed by both the PARTIES.
17.2		This agreement shall be terminated at any time by either PARTY by giving 30 clear days of written notice to that effect, giving reasons thereof. However the termination of the COURSE shall come into force from the subsequent Academic Year only.
17.3		The PARTIES shall abide to the condition that the termination shall not affect the ongoing COURSE. Which shall be fully completed as per the Agreement.

#### 18.0 Intellectual Property Right (IPR):

18.1		The Intellectual Property Rights in the results arising from the Course under this Agreement, if any, which has the potential of commercial or otherwise importance shall be vested with both the PARTIES.
18.2		The PARTIES agree that they shall not take any action which will jeopardize securing Intellectual Property Rights for the results arising out of the COURSE.

#### 19.0 Force Majeure:


19.1		Neither Party shall be held responsible for non-fulfillment of their respective obligations under this Memorandum due to the exigency of one or more of the Majeure event such as but not limited to acts of God, War, Flood, Earthquakes, Strikes, Lockouts, Epidemics, riots, Civil Commotion, etc., provided on the occurrence and cessation of any such event the party effected thereby shall give a notice in writing to other party within one month of such Occurrence or cessation.
