Background of the Parties

Krishna University: This First Party

Krishna University was established by the Government of Andhra Pradesh in 2008 through the Krishna University Act, 1981, situated in Machilipatnam. The University started functioning with effect from August 8, 2008. The University has jurisdiction in Krishna District and 167 colleges/institutions affiliated with its administration and have the student strength of over 0.65 lakhs studying in Diploma, PG Diploma, UG, PG, M.Phil., Ph.D programs in multi-disciplinary areas.

Youth4Jobs Foundation (Y4J): Second Party

Youth4Jobs Foundation (Y4J) herein referred as Youth4Jobs located at 21-7-587, Near High Court, Khokarwadi, Hyderabad-500002, Andhra Pradesh, India registered under section 25 of the Companies Act, 1956) No.1 of 1956) as a private limited with corporate identity number U80901AP2012NPL078912/2011-12 with its head office in Plot 135, Ave 2 Road No. 13, Banjara Hills, Hyderabad-500034 represented by the Founder-CEO of the Foundation.

Youth4Jobs is a Not-for-Profit national organization, which sets up placement linked skilling centres for youth with disability. The work of the organization has scaled form one State to thirteen States; form one training Centres to twenty-two Training Centres in six years. Youth with Physical, Speech & Hearing impairment and with low vision are enrolled in the programs and are linked to job opportunities. Youth4Jobs also works closely with companies in building a more inclusive workforce. Youth4Jobs offers companies a comprehensive end-to-end solution in promoting inclusive hiring service. Youth4Jobs has won several awards nationally and internationally.

Youth4Jobs launched a new program "Smart Inclusion Center" which collaborates with colleges/Universities/Institutions to orient and to link candidates with disabilities to jobs.

Objectives of this MoU:

The aim of this agreement is to provide training and placement for students with disabilities. For the said purpose, the Youth4Jobs domain expertise in education services for students with disabilities will be shared.

The collaboration will focus on:

- Organizing awareness and orientation programs 'on disability' to the Faculty of University, Colleges and School Teachers.
- Organizing transition campus and training programs for students with disabilities entering higher education.

- Providing training to students with disabilities enrolled in Higher Education for employability and place them in appropriate jobs.

In pursuance thereof, the Organizations have decided to sign a MOU in writing their roles and responsibilities towards fulfilling the above said objectives

Joint Roles (KrU-CDAP) and Youth4Jobs:

- From both the organization, one-one single point of contact person (Program Executive) will coordinate the work.
- Jointly plan the programs and student-parent counselling sessions.
- Jointly place the organizations names and logos on the communication material-Banners, Information Kit, etc., with prior permission from both the organizations.
- Jointly, do research and case studies on Persons with Disabilities.
- Jointly develop training manuals and booklets.
- Jointly organize disability awareness and sensitization programs.
- Jointly update the student information and progress on the Krishna University and Youth4Jobs online MIS System.

Program Executives

For effective implementation and monitoring of the program as envisaged in the MoU, Ramesh Duraikannan, Program Manager – College Connect shall represent 'YOUTH4JOBS FOUNDATION' & the Registrar, Krishna University shall represent KrU, MTM.

Project Fellow

To coordinate these programs, one project fellow will be appointed by Y4J, for whom the payment will be made by Youth4Jobs. The person will work in coordination with the Registrar, KrU.

Term and Renewal:

This agreement shall remain valid initially for a period of **five years** from the date of execution hereof. Any renewal thereafter must be expressly agreed in writing by both parties failing which this agreement shall be deemed to have end by efflux of time. This agreement may be terminated by either party giving one month written advance notice to the other, if required. Both the organizations shall not use logo, emblem or brand name of either in their advertisements, pamphlets or brochures or websites without the written permission of the Head of the organizations.

1. Resolution of Disputes: the parties agree to resolve any differences or disputes arising from this agreement by mutual discussions.
2. Legality and Ethics: Both parties agree to observe highest standards of legality and ethics.
3. All the terms and conditions of this MoU are subject to the approval of the various bodies of the University and the provisions of the Rules and Regulations of the University.
4. The parties are at liberty to amend the clause under this agreement by mutual consent.




