Applications are invited from eligible faculty members for promotion under the Career Advancement Scheme (CAS) as per UGC regulations on Minimum Qualifications, G.O.Ms.No. 14, Higher Education (UE-II) Department, dt.13.02.2019 and G.O.Ms.No.20, Higher Education (UE-II) Department, dt.28.06.2023 for Appointment/Promotions of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education 2018, as applicable.

As per UGC Regulations 2018:

1. Assistant Professor (Academic Level 10) to Assistant Professor (Senior Scale / Academic Level 11)
2. Assistant Professor (Senior Scale / Academic Level 11) to Assistant Professor (Selection Grade / Academic Level 12)
3. Assistant Professor (Selection Grade / Academic Level 12) to Associate Professor (Academic Level 13A)
4. Associate Professor (Academic Level 13A) to Professor (Academic Level 14)
5. Professor (Selection Grade / Academic Level 14) to Senior Professor (Academic Level 15)

The incumbent fulfilling the eligibility criteria of UGC-CAS shall download the **application form from the official website of KRU at the link www.kru.ac.in** and the Eligibility cut-off date for counting of service is 31-12-2024. Five sets of hard copies of the applications along with self-attested enclosures supporting API / Research scores in the prescribed form duly recommended and forwarded by the respective Head of the Department and Principal should be submitted to **The Registrar, Krishna University, Machilipatnam** on or before 31-01-2025 by 4.00 PM.
